

THE BITCLUB SAGA

“Indeed, no more than (an affidavit) is necessary to make the Prima fascia case.”

United States v. Kis, 658 F.2d, 526, 536 (7th cir., 1981);

I, Joby of the family Weeks, a living man, one of “the people” as mentioned in the constitution **am claiming whistle blower protection**. Most people reading this probably don’t know much about me, but I’m sure you know about **Bitcoin**. I was an early pioneer in the crypto currency movement and traveled to 175 countries around the world sharing the technology with everyone I came across. I bought my first stack of Bitcoins for less than \$1 to give some perspective of how long I’ve been going at it. I helped design the famous Bitcoin logo that practically everyone on earth has seen and I helped create some to the largest Bitcoin mining data centers in the world.

Since then, I have uncovered crimes more momentous than anyone reading this could ever imagine! This is 10x bigger than what Julian Assange with Wikileaks and Edward Snowden exposed. I have laid out the crimes as thoroughly as possible in these documents that I’ve written below. **Billions of dollars in damages** have occurred because of the illegal actions of over 80 individuals that I name herein. Some very famous people are involved in the cover up of these crimes including politicians, judges, prosecutors, lawyers, and agents of all the 3 letter agencies you’ve heard of. Everyone is on the take. The coordinated actions of the SEC, FBI, IRS, DOJ, courts, and their co-conspirators demonstrate the hallmarks of a criminal enterprise: a repeated and organized pattern of fraud, extortion, defamation, and jurisdictional overreach aimed at seizing assets and consolidating control over the digital asset market. This will be a great movie one day. I want you to know that **I’ve always lived my life above reproach and I am not suicidal!**

How did I uncover these crimes you may be asking yourselves? Completely by accident actually! It all started out Dec 10th 2019 when I was wrongfully accused of several victimless “crimes” and was unlawfully detained for these past 5 years. (11 months of it was being bounced around the country from jail to jail to jail and 4+ years with an ankle bracelet imprisoned on house arrest) I harmed no people and I broke no laws that I am subject to yet I was still kidnapped, jailed, denied my “due process” constitutional right to bail and a trial, and tortured until I feared I would be killed. They wouldn’t stop the cruel and unusual punishment until I plead guilty to “code violations/infractions”. I.e. Non “crimes”, of which I wasn’t indicted for and am innocent of. After I “admitted” that 2+2=5, I was granted bail.

The government then commandeered my parents home in Denver to use as a Federal Detention Center. They told me that if I help them “catch criminals”, they would give me a co-operation agreement called a 5k letter, so that I could get a “light sentence” for the “non crimes” they forced me to admit to committing. **So, I went to work. It took me 4 years to uncover literally the biggest criminal syndicate in American history, documented herein.**

My many BAR member attorneys, whom have milked millions of dollars out of me over the years, have not helped me at all to present evidence in this case of all the crimes that are taking place in our country. (This is called a “misprision of a felony”) Yet, that’s what the government wanted me to do! Help them catch criminals. I participated as a member, domiciled in Mexico, using my Mexican ID, citizenship and address so as to remain compliant with Bitclub's KYC and membership agreement. For the record, I am NOT an 8 USC 1401 US CITIZEN. I am an American National "Nonresident alien". I had been a perpetual traveler, never spending more than a week or two in a row anywhere, for 15 years, prior to this ordeal. After visiting/vetting 175 countries to see which countries were the best to eventually settle down and start a family. I decided to buy a home in St. Kitts for the citizenship by investment program that they were offering along with obtaining citizenship status in several other countries as well. I am also a diplomat for an IGO (Intergovernmental Organization) that has treaties with 40+ countries around the world too. I would travel the world on my diplomatic passport. The tax forms that I was advised to file over the years were 1040NR forms since I am "classified" a "non resident alien". Being a perpetual traveler, never staying anywhere long enough to meet the residency requirements of any jurisdiction was a unique and different way to experience life. My mission was to go everywhere and do everything and I was well on my way to achieving that goal. I am an outspoken lover of liberty, philanthropist and am on a mission to free humanity and help create heaven on earth.

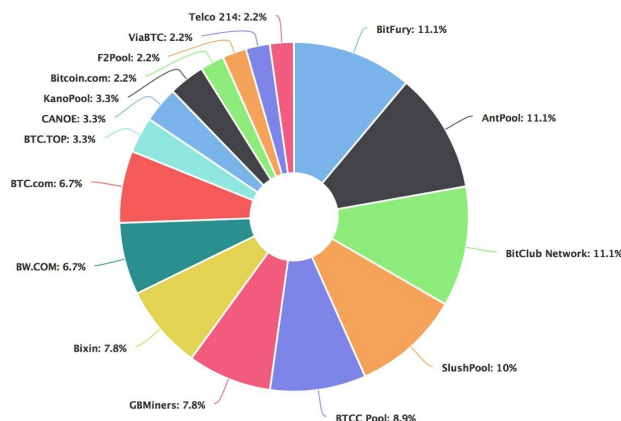

The wallet **0xF3b9D2c81f2b24b0fa0ACa-Aa865b7D9CED5FC2fb** had its first transaction on **December 23, 2016**. Between that date and **December 10, 2019** (1,083 days), it mined approximately **391,479 ETH** (including blocks and uncle rewards), averaging **~361.5 ETH per day** over the period.

I felt comfortable becoming a member of Bitclub when I saw the proof that they were doing what they said they were doing. At the time, they were mining an average of 50 BTC a day and 360 ETH a day. (See for yourself above) The crypto that was mined, less the operating expenses, was distributed to the members on a daily basis. Bitclub did not touch the U.S. financial system and they did not accept dollars/ fiat. They only traded Bitcoin for mining equipment, which members could either take delivery of or have hosted at one of the Bitclub data centers. Bitclub was experiencing explosive growth. It was a unicorn, out pacing google, apple, and amazon. More than a million people from over 100 countries joined the Bitcoin movement. Today that number would be in the tens of millions had it not been for the illegal government intervention.

2. ****Due Diligence and Contributions****

As part of my due diligence, I traveled to Iceland to verify the operations of Bitclub's mining facility. I verified the claims made by the founders and saw that everything was on the blockchain, visible for the world to see. **It cant be hidden or faked.** The Blockchain is a record of truth. In my interactions with the Bitclub founders, I made a connection with a company called Bitfury, a competitor of Bitmain, which helped Bitclub secure mining equipment at a better price, saving Bitclub members approximately 3,000 BTC. Additionally, I found better power sources, saving Bitclub members at least 2,000 BTC annually off the power bill. I helped them build the biggest bitcoin mine on earth at the time!

3. ****Advocacy for Bitcoin****

I became an advocate for Bitcoin and its distributed ledger of truth. I traveled to over 175 countries to promote its adoption. I gave away thousands of Bitcoin and helped countless people set up wallets, believing in the potential of Bitcoin to solve global issues. The popularity of Bitcoin soared making it one of the most valuable assets on earth which validated my belief in the technology. Unfortunately, I became a target of hackers and thieves and had thousands of Bitcoins stolen from me.

4. ****Involvement with U.S. Authorities****

In 2019, the U.S. government initiated a secret investigation into Bitclub. I found out about the investigation and reached out, voluntarily, to meet with government agents to provide information about the operations of Bitclub, the hackers attacking its members, the fake Bitclub websites that were popping up, scamming people and how the government could prevent further harm to Bitcoin users in general. Despite offering to help identify and capture cybercriminals that give Bitcoin a bad reputation, the agents were uninterested. During this time, I continued to believe in the integrity of Bitclub and its founders, who had shown transparency and a commitment to doing the right thing.

5. ****Arrest and Legal Proceedings****

On December 10, 2019, I was arrested and falsely charged with "conspiracy to commit wire fraud" and "conspiracy to sell unregistered securities" related to Bitclub's activities. I had no knowledge that anything illegal was occurring. I was not involved in the management, creation or operation of Bitclub, which was a private membership association. I had no criminal intent to defraud or harm anyone. And the government doesn't allege that my actions created any victims. I've never had the chance to face my accuser. I was just a vendor sourcing computer equipment for the club and a happy member. The physical computer equipment I sourced for Bitclub is a product, NOT a security because it didn't generate money. **Bitcoin isn't money.**

The prosecution's false allegations of Bitclub being a \$700m scam does not account for the fact that Bitclub had actually mined for its members close to 100,000 Bitcoins! Did the prosecution team forget that every satoshi can be tracked on the blockchain for the world to see?

6. ****Unlawful Government Intervention and Harm to Victims****

The government's shutdown of Bitclub led to the loss of tens of thousands of Bitcoin, both for the members and for myself. Since the government's actions, Bitclub members, including myself, have not been able to access our accounts or recover our Bitcoin. **I am one of the victims in this case**, not a perpetrator. The government's unlawful intervention in this private membership association, which did not involve the U.S. financial system or money, has caused irreparable harm to the million + victims, including myself. Based on my extensive studying of the law, **the government had no jurisdiction** to get involved since Bitclub was not using money or selling securities or was even a regulated company for that matter. If you read the defective indictment against the "rest/trust", you will notice that JOBADIAH WEEKS is mentioned only twice and both times its an email of me asking the owners of the club to do the right thing and never the wrong or illegal thing. My lawyers asked, "How does someone get indicted for that?" I felt like I was in the twilight zone!

7. ****Injustice, Due Process Violations and Personal Hardship****

I was denied bail, denied a trial, subjected to prolonged unlawful imprisonment, and forced, with the threat of death, to admit to “crimes” I did not commit, under duress. I have lost my family, my stellar reputation, my assets, and my rights, **without due process**, including my 2nd Amendment right to defend myself even though I harmed no one. **The government’s actions have caused irreparable harm to me and to 1,000,000+ other Bitclub members from around the world who are victims of their unlawful intervention illegally trying to claim world wide jurisdiction and crush the crypto currency movement.** The government has attempted to paint me as a criminal, but I am not one. I have always acted in good faith, and I did not break any laws that I am subject to or harm any people. My name has been slandered globally and my wealth plundered.

8. **Justification for a counter suit**

At the time of my kidnapping, Bitclub was mining around 50 Bitcoins each DAY! The government shut down the club 1800 days ago. That is a loss to the members, due to illegal government intervention, of 90,000 Bitcoins. They were also mining 360 ETH a day. That is a loss to the members, due to illegal government intervention, of 650,000 Etherium.

There is also precedent that the government must pay \$75k an hour for illegal detainment false arrest and kidnapping etc, **ie violation of due process.** Thats equals approximately \$3.5 Billion dollars over the last 1800 days. See Trezevant v. City of Tampa.

Thus, since the government hasn’t given any of the Bitcoin that they stole back to the million plus Bitclub members or myself (after more than 5 years!), I’m now justifiably forced to bring forth against the government and their officers **a multi billion dollar counter claim suit!** I’m still on house arrest 5 years later. I’ve never been convicted of or sentenced for a crime and should not be. What they have done is so wrong. If the government had any evidence of any wrong doing on my part, they would have taken us to trial and convicted us years ago. **The weaponization of the DOJ and the law fare against freedom loving people** who don’t want to be CBDC social credit score slaves, like the unfortunate folks in China and elsewhere, **must stop!** This is the biggest Bitcoin case in the world and its important to right this wrong thats taken place. This suit and future judgement that I win against the government and the individual members involved in violating our rights is the only remedy that will make the million plus Bitclub members, including myself, whole! I appreciate your prayers for justice to prevail!

And now, **I’m going to speak directly to the accused members of this RICO criminal enterprise.**
